Plan Commission Meeting Minutes

Chairman Luther called the Plan Commission Meeting to order in the City Hall Council Chambers on Monday, April 28, 2025 at 7:00 p.m.

1. Roll Call: Jeff Luther, Steve Lindberg, Dennis Kropp, Steve Cook, and Dick Martinson. Mark Kalscheur and Cody Gentz was absent. Others Present: David Schofield, Dave Kowieski, Don Myers (AFT Real Estate).
2. Approval of Minutes: Lindberg moved to approve the March 31, 2025, Plan Commission minutes with a second by Cook. Motion carried.
3. Public Comments: Myers introduced himself and spoke in favor of the certified survey map.
4. Items of Discussion:
 - a. Schofield presented the proposed certified survey maps from Land of Opportunity, LLC, Brandenburg Revocable Living Trust and Michael Dehne. Schofield indicated that Land of Opportunity, LLC has proposed a certified survey map to split their property on Oak Avenue into two lots available for commercial development. Schofield indicated that Brandenburg Revocable Living Trust has proposed a certified survey map to merge and split their property on USH 12 into three lots, with TMS Tire & Auto remaining on one lot and the other two lots available for commercial development. Schofield noted that the certified survey maps show a utility easement across the TMS Tire & Auto lot to serve the middle lot on USH 12. Schofield noted that the certified survey maps show access restrictions onto USH 12. Schofield indicated that Michael Dehne has proposed to purchase one lot from each of the proposed certified survey maps and has proposed a certified survey map to merge them into a single parcel for the purpose of building a new Culver's Restaurant. Schofield noted that City Staff have several technical review comments regarding the proposed certified survey maps and recommend that any approval be contingent upon the applicant addressing said comments. Kropp moved to approve the certified survey maps from Land of Opportunity, LLC, Brandenburg Revocable Living Trust and Michael Dehne, as presented, contingent upon the applicant addressing City Staff's technical review comments, with a second by Lindberg. Motion carried.
 - b. Item #4B addressed above.
 - c. Item #4C addressed above.
 - d. Schofield indicated that the next Plan Commission meeting is scheduled for Tuesday May 27, 2025 due to Memorial Day. Schofield noted that an annexation request is expected in the near future. Martinson asked about the comprehensive plan update. Schofield noted that City Staff plan to begin tackling this in Q3 or Q4 2025, followed by a review of the zoning and subdivision codes. No actions taken.
5. Martinson moved to adjourn with a second by Lindberg. Motion carried.


- Location Map


