Menomonie Fire Department

Starting July 1, 2022 all mobile food establishments operating within the City of Menomonie shall require a license. As part of the licensing process, a fire safety inspection will be required. The following items will be part of the inspection and are considered minimum safety standards set forth in the latest edition of the National Fire Protection Association, Fire Code (NFPA 1). It is our goal to assist you in ensuring you have all the necessary equipment onboard to prevent or mitigate fires, explosions, and other hazards while serving your customers.

We are providing this information now to give each vendor sufficient time to ensure the following items are installed and operational before July 1, 2022. Please contact the fire department at 715-232-2414 with any questions concerning the following information.

FIRE PROTECTION

1. Cooking equipment that produces grease-laden vapors requires a Type 1 kitchen exhaust hood.
2. Type 1 kitchen exhaust hoods require an automatic fire-extinguishing system compliant with UL 300 standards.
3. A minimum of one 2A:10BC (2A: 20BC when a generator is used) fire extinguisher and one 1.5-gallon Class K extinguisher are required for up to four fryers with a medium capacity of 80 pounds. A water extinguisher is required for solid fuel cooking appliances.
4. Gas cooking appliances must be secured and connected to the fuel supply piping with an appliance connector complying with ANSI Z21.69/CSA 6.16
5. Cooking oil storage containers must not exceed 120 gallons, must be properly secured and must be listed for their use (UL 80, UL 142).
6. Cooking oil tanks must have normal and emergency venting capabilities.
7. A "NO SMOKING" sign shall be posted on the exterior of the vehicle near the gas supply.

MAINTENANCE

1. Exhaust systems – including hood, grease removal fans, ducts and other accessories must be inspected and cleaned regularly.
2. Fire extinguishers must be recertified annually.
3. Automatic fire extinguishing systems must be serviced every six months.
4. LP gas containers and fuel-gas piping systems must be inspected annually and labeled by an approved U.S. Department of Transportation inspection agency.
5. CNG containers must be inspected every three years and not used past the listed expiration date.
6. The inspection agency must label the fuel gas system with a tag indicating the name of the agency and date of the inspection.
7. All electrical devices must be properly maintained.

LP AND NATURAL GAS FUELED EQUIPMENT

1. The maximum aggregate capacity of LP gas containers used in food trucks is 200 pounds.
2. LP gas containers must be securely mounted and restrained.
3. LP gas containers must meet NFPA 58 requirements for design compliance.
4. The maximum aggregate capacity of CNG containers transported by the vehicle as 1,300 pounds of water capacity.
5. CNG containers must be NGV-2 and must be properly secured.
6. When CNG containers and system are used to supply fuel for cooking as well as transportation, they Must be installed in accordance with NFPA 52.
7. Piping for LP gas systems, including valves and fittings must be protected from tampering, impact damage and damage from vibration.
8. The vehicle must have a listed LP gas alarm in the vicinity of the LP gas components and installed in accordance with manufacturer's instructions.
9. All CNG components and system piping must be safe from tampering, damage and impact during Transportation and use.
10. Vehicles using CNG must have a Methane alarm.
11. If an open flame heat source is used within the vehicle, a carbon monoxide detector shall be installed.

INSPECTION

All mobile food vehicles are subject to fire inspections.

1. The Menomonie Fire Department shall inspect all mobile food vehicles as part of the licensing requirements in Title 3, Chapter 23 of City Code.
2. Mobile food vendors can call the fire department at 715-232-2414 to schedule an inspection. You must call at least 2 business days prior to the desired inspection date.
3. A signed inspection form will be issued by the fire department to the mobile food vendor as proof of fire code compliance. This form will need to be presented to the city clerk.
4. Mobile food vehicles that are found not in compliance shall have violations corrected and can call for a reinspection.
5. A copy of the inspection form must be maintained within the mobile food vehicle for review.
